I have also been informed about the following specifications:

- the aforementioned list has been drawn up in conformity with the agreement that is concluded between the Belgian hospitals and insurance organisations. (This agreement is available for consultation at the Registration desk of the OLV Hospital).
- The undersigned is advised to inform himself about the content of the goods supplied
- All amounts in compensation of the aforementioned goods and services supplied to either hospitalised or ambulant patients, for which there is no medical indication – excluding the services of the hair dresser and the paediatrician – can only be collected by the central collection department of the hospital, based on the legal invoice (cf. the aforementioned agreement); the materials for laparoscopic surgery is being charged in the cost category 'costs for implants, prostheses and non-implantable medical devices'; the other products are being charged in the cost category 'miscellaneous costs'.

I also sign for acceptance of the following stipulations:

- The above-mentioned prices of products and services are possibly subject to revision, following a simple decision of the management of the OLV Hospital
- Should any changes of the prices for products and services occur after the moment that the patient or his/her representative have signed this document, the latter parties should be informed thereof as soon as possible and should be invited to sign an adjusted acceptance certificate in replacement of the previously signed certificate.
- Upon request of the patient or his/her representative, the complete pricelist for products, services and fees, for which the health insurance does not provide any compensation and which can, when used, can be charged by the hospital, should be made available for consultation
- In case of non-payment of the invoice within 14 days following the due date, the patient will be due an arrear of 7% per annum on the outstanding amount; this arrear will be claimable even without notice of default
- When the above-mentioned amounts will remain partially or entirely unpaid on the due date, a compensation equal to 10% of the outstanding amount still due, and with a minimum of EUR 25.28, will have to be paid to the OLV Hospital on top of the outstanding amount, without the need of a preceding notice of default. An identical settlement is applicable to the hospital when it receives an undue payment from the patient.
- In case of dispute, either the court of first instance at Dendermonde (Belgium) or the peace court of the second county Aalst (Belgium) are competent, depending on the size of the claim.

The undersigned accepts unconditionally the aforementioned declaration and price list.
